# OPM SOLICITS FEDERAL HEALTH INSURANCE CARRIER PROPOSALS FOR NEW SELF-PLUS-ONE OPTION IN 2016

In their annual Federal Employee Health Benefits Program (FEHBP) Carrier Letter dated 13 March, the Office of Personnel Management (OPM) has asked the approximately 250 carriers who offer health insurance plans to federal employees, federal retirees, and survivor annuitants to provide proposed premium rates for the new Self-Plus-One FEHBP Option which is scheduled to go into effect on 1 January 2016. Upon receipt of these proposals, OPM and each of the carriers will formally negotiate the final premium rates for the Self-Plus-One Option. OPM believes that the premiums for Self-Plus-One will be lower than the Self and Family Option but higher than the Self Only Option. OPM estimates that thirty percent of the current Self and Family enrollments in FEHBP have only one eligible family member in addition to the individual premium payer, and usually consists of a married couple with no children under the age of 26. The new Self-Plus-One Option will be available for the first time during the 2015 Open Season, which this year runs from 9 November through 14 December. This new option, if chosen, will become effective on 1 January 2016.

#### CPI-W BEGINS TO REFLECT UPWARD TREND IN FEBRUARY AND MARCH

The Consumer Price Index for Urban Wage Earners and Clerical Personnel (CPI-W), used to determine if Social Security recipients, federal retirees, and survivor annuitants will receive a Cost-Of-Living-Adjustment (COLA) in 2016, turned upward in February and March 2015 after declining in each of the four months from October 2014 through January 2015. The February CPI-W increased by 0.50 percent to 229.421 and the March CPI-W increased by 0.71 percent to 231.055.

The March CPI-W of 231.055 was 1.36 percent lower than the average CPI-W for the months of July-September 2014, which was 234.242. The 234.242 figure is the reference number for determining if there will be a COLA in January 2016. The CPI-W for April will be announced on 22 May.

The Team was asked to focus on eight recommendations from the Future of NARFE Committee Report:

Rec. 4: Board of Directors (BOD)—What is the most efficient structure of the Board?

Rec. 12: Establish regionally BOD function as policy makers—Review the authorities provided the Board. Move toward agile governance.

Rec. 13: BOD set annual dues as part of the budget process (See 12 above).

Rec. 18: Assess federation operations/state advocacy structure.

Rec. 19: Study reduced federation funds.

Rec. 22: Establish Congressional District Leaders (CDLs) in all districts.

Rec. 27: Local chapter membership will be optional.

Rec. 28: NARFE members - member of Congressional District Action Team.

An overarching goal and three specific goals were developed as a result of the meeting (Click here for Strategic Goals attachment):

#### Ensure/Secure the Future of NARFE

- Transform governance to be more efficient, effective, agile, consistent and accountable.
- Establish a consistent brand to increase awareness, eliminate confusion and convey the value of NARFE.
- Stabilize and grow membership to support effective advocacy and to deliver financial stability.

The Strategic Planning Team and Committee discussed a number of specific, actionable items in support of these goals. As the Strategic Planning process moves forward and action items are vetted by the National Executive Board, I will share them with you.
