Service Officer Report (Jim Kielty)

CPI-W CONTINUES TO RISE FOR PERIOD OF JANUARY-MARCH 2017



The Consumer Price Index for Urban Wage Earners and Clerical Personnel (CPI-W), used to determine if Social Security recipients, federal retirees, and survivor annuitants will receive a Cost-of-Living Adjustment (COLA) in 2018, showed a steady increase during the months of January, February, and March 2017. In order to determine if there will be a 2018 COLA, the monthly CPI-W figures for July, August, and September 2017 will be averaged and compared with the CPI-W average for July, August, and September 2016, which was 235.495. The CPI-W average for July-September 2017 must exceed the 235.495 reference point to trigger a 2018 COLA. The January CPI-W was 236.854, rose to 237.477 in February, and again increased to 237.656 in March 2017. The 237.656 figure for March is now 1.11% above the 2016 reference point of 235.495. If this upward trend for the CPI-W continues through September 2017, there is a strong likelihood that the 2018 COLA will exceed the 2017 COLA, which was 0.3%.

TRUMP ADMINISTRATION EXPECTED TO RECOMMEND 1.9 PERCENT PAY RAISE FOR FEDERAL EMPLOYEES IN 2018

Reports from Washington, DC appear to indicate that the Trump administration plans to recommend a 1.9% pay increase for federal employees when the 2018 federal budget proposal is released in mid-May. Any proposed increase is subject to Congressional approval. If a 1.9 percent increase is approved, it would be consistent with the increases federal employees have received in recent years. During the period of 2014 through 2017, federal employees have received raises of 1.1%, 1.3%, and 2.1%, respectively.
