Budget Update as of 30 September 2017

Total income to date is \$2,109 (\$1,171 in chapter dues and \$938 net from our April garage sale). Dues are a direct deposit from NARFE National monthly. I reviewed the previous years and we historically have received about 56% of the total annual dues. I am projecting that we will receive about \$920 more from National in dues. With the transfer in of members from Deming and Silver City our current membership is 307. Funds have been transferred from both chapters to our account. The garage sale was budgeted to bring in \$900 so we received 4% more than expected. The Chapter Liability insurance, Post Office Box Rent, and Document Storage Fee have all been paid for the 12-month period after they became due. The per capita membership dues to NM Federation of Chapters will be due in January 2017 and based on our current membership will be \$541. This amount may be adjusted by any additions or losses. The expenses for the registration of our delegates to both the T or C Workshop and the Region VII Conference were 52% of the budgeted amount. Based on the information available, there are sufficient funds available for committee expenses budgeted for FY2017 - 18.

HEALTH BENEFITS OPEN SEASON BEGINS NOVEMBER 13



The Open Season for the Federal Employees Health Benefits Program (FEHBP) and the Federal Employees Dental and Vision Insurance Program (FEDVIP) will begin on Monday, November 13, and will conclude on Monday, December 11. During this Open Season, current federal employees, federal retirees, and survivor annuitants may change plans, options, and types of enrollments (Self, Self Plus One, and Self and Family), or make any combination of these changes. Open Season for the Federal Flexible Spending Account Program (USAFEDS), available only to current federal employees, also runs concurrently with the FEHBP and FEDVIP Open Season.

The U.S. Office of Personnel Management (OPM) will send federal retirees and survivor annuitants basic details on Open Season and guidance on how to obtain information and materials. This will be done either by regular mail or electronically if you have provided OPM with your e-mail address. Those who have not received this information by the beginning of Open Season on November 13 should contact OPM. All FEHBP plan brochures can be viewed and printed at the following website: www.opm.gov/healthcare-insurance. If you do not have access to a computer, call the customer service number on your health insurance ID card to obtain brochure information.

NARFE members who currently are enrolled in the New Mexico Blue HMO Preferred health plan should be aware that this plan WILL NOT BE OFFERED to FEHBP enrollees in 2018. Members may recall that the New Mexico HMO Blue Preferred plan was once the Lovelace HMO before being taken over by Blue Cross/Blue Shield several years ago. All current New Mexico Blue HMO Preferred enrollees should have received a letter advising them that the plan will not be offered in 2018 and that they should select another health plan during the upcoming Open Season. Attached to the notice is a listing of all FEHBP plans available in New Mexico. If you fail to take action to change from the New Mexico Blue HMO Preferred health plan by the end of the Open Season on December 11, you will automatically be enrolled in the lowest cost nationwide plan option as determined by OPM. NARFE members also should be aware that several types of Aetna health plans will be available in 2018 to FEHBP enrollees who live in Dona Ana County, which is now part of the Aetna service area.

The October and November issues of the *NARFE* magazine contain a great deal of Open Season information and the December issue of the magazine also will address the topic. A listing of the 2018 monthly premium changes for six (6) of the most popular FEHBP plans is shown below.

SEPTEMBER CONSUMER PRICE INDEX RISE WILL RESULT IN TWO PERCENT COLA IN 2018

The Consumer Price Index for Urban Wage Earners and Clerical Personnel, used to determine if Social Security recipients, federal retirees, and survivor annuitants will receive a Cost-Of-Living-Adjustment in 2018, rose to 240.939 in September 2017. When combined with the CPI-W for July (238.617) and August (239.447), the 2017 third quarter average CPI-W of 239.668 is two percent greater than the reference point of the average CPI-W for the third quarter of 2016, which was 235.057. This two percent COLA increase will go into effect on January 1, 2018.

Although the two percent COLA for 2018 is welcome news when compared with the 0.3 percent CO-LA in 2017, federal retirees and survivor annuitants will be facing an average 6.1 percent increase in Federal Employees Health Benefits Plan (FEHBP) premiums in 2018 as well as a possible increase in monthly premiums for Medicare Part B. An announcement on Medicare Part B premiums is expected soon.



Membership VP & Chapter Historian (Dan Carroll)

Historian notes: After a dogged search our chapter's charter dated May 26, 1952 was located in storage and it revealed that our chapter (182) had its 65th anniversary on May 26, 2017. The organization was then called the National Association of Retired Civil Employees. The organization now called NARFE was formed in February 1921 as ARFE – Association of Federal Employees. In 1924 the name was changed to NARFE – the National Association of Retired Federal Employees. In 1947 the organization became NARCE – National Retired Civil Employees. In 1970 the name was changed to National Active and Retired Federal Employees (NARFE) to include active as well as retired federal employees. It remains NARFE to this day. I'll bring the charter to the November meeting for your viewing pleasure.
