# CONSUMER PRICE INDEX FIGURES FOR OCTOBER-DECEMBER 2017 REFLECT SLIGHT UPWARD TREND

The Consumer Price Index for Urban Wage Earners and Clerical Personnel (CPI-W), used to determine if Social Security recipients, federal retirees, and survivor annuitants will receive a Cost-Of-Living-Adjustment (COLA) in 2019, stood at 240.526 in December 2017 after registering 240.573 in October and 240.666 in November. The 240.526 CPI-W figure for December is 0.36 % higher than the 2017 CPI-W average for July-September 2017, which was 239.668.

To determine if there will be a COLA in 2019, the CPI-W figures for July, August, and September 2018 will be averaged and compared with the July-September 2017 CPI-W of 239.668, which is the reference point for determining if there will be a COLA in 2019.
