I attended the re-election campaign for Congresswoman Torres Small in Las Cruces. I spoke with her and thanked her for her support to NARFE. She thanked NARFE for their service to Federal employees and reminisced about her visit to Chapter 0182 last September. She remarked that our members were very friendly and that our chapter showed support for what NARFE is trying to protect...our earned benefits.

CONSUMER PRICE INDEX FIGURES FOR OCTOBER-DECEMBER 2019 REFLECT SLIGHT DOWNWARD TREND

The Consumer Price Index for Urban Wage Earners and Clerical Personnel (CPI-W), used to determine if Social Security recipients, federal retirees, and survivor annuitants will receive a Cost-Of-Living-Adjustment (COLA) in 2021, stood at 250.452 in December 2019 after registering 250.894 in October and 250.644 in November. Despite these monthly declines, the 250.452 December CPI-W figure is still 0.10 % higher than the CPI-W average for July-September 2019, which was 250.199.

To determine if there will be a COLA in 2021, the CPI-W figures for July-September 2020 will be averaged and compared with the July-September 2019 average CPI-W of 250.199, which is the reference point for determining if there will be a COLA in 2021. The July-September 2020 average must exceed the July-September 2019 average for a COLA to be authorized in 2021.



PREPARATIONS FOR 2020 U.S. CENSUS WELL UNDER WAY

As required by Article 2, Section 1 of the Constitution, the United States government is required to count our population every ten years. The 2020 Census will mark the 24th time that the country has counted its population since 1790. The 2020 Census will count the population in all 50 states, the District of Columbia, and the 5 U.S. territories (Puerto Rico, American Samoa, the Commonwealth of the Northern Mariana Islands, Guam, and the U.S. Virgin Islands). The Census count already has begun in remote Alaska locations, with the village of Tooksook Bay holding the distinction of being the first location to have its population counted in the 2020 Census.

By April 1, 2020 every home in the United States should have received a notice to respond to the 2020 Census questionnaire in one of three ways: by phone, by mail, or online. This will mark the first time that individuals will be able to respond online. NARFE members are encouraged to complete their Census questionnaires promptly, since the population count determines the number of seats each state has in the House of Representatives, and the figures are used to draw federal and state legislative districts which will be in use for the next 10 years. The population counts in each state also determine how billions of dollars of federal funds are allocated. Prompt and accurate completion of the 2020 Census questionnaire is particularly important in New Mexico, since our large rural population and the number of small remote communities may make an accurate count more difficult.
