CONSUMER PRICE INDEX FIGURES RISE IN JANUARY AND FEBRUARY, BUT CORONAVIRUS MAKES 2021 COLA UNCERTAIN

The Consumer Price Index for Urban Wage Earners and Clerical Personnel (CPI-W), used to determine if Social Security recipients, federal retirees, and survivor annuitants will receive a Cost-Of-Living-Adjustment (COLA) in 2021, stood at 251.361 in January 2020 and 251.935 in February The 251.935 February CPI-W figure is 0.69% higher than the 2019 CPI-W average for July – September 2019, which was 250.199. However, as all NARFE members realize, the rapidly developing coronavirus pandemic is causing havoc in many sectors of the economy, and the possibility of a 2021 COLA is totally uncertain at this time. The March 2020 CPI-W, which is scheduled to be released on April10, should give an early indication of the impact of coronavirus on chances for a CO-LA in 2021. Stay tuned.

Much to the chagrin of federal employees, the OPM Director, Dale Cabaniss, resigned her position on March 17, 2020. NARFE President, Ken Thomas, stated "This is now the second time this agency has lacked a Senate-confirmed director in the middle of a national emergency, the other of which was the unprecedented 35-day government shutdown." The Director had clashed with the Office of Management and Budget (OMB) and White House over the proposed OPM merger with the General Services Administration (GSA). Michael J. Rigas is the Acting Director of OPM. He has 20 years of experience in private, public and non-public sectors.

This week, the Senate is expected to pass phase II of the stimulus package. No one knows just how the payments will be handed out but say they will be handed out in two equal payments, April 6 and May 18.

We must all do our part to stop COVID-19 from spreading. Please follow the guidelines set out by the federal, state, and local government and STAY SAFE.
