# INFLATION TRIGGERS SIGNIFICANT RISE IN CONSUMER PRICE INDEX FROM APRIL THROUGH JUNE 2021



The Consumer Price Index for Urban Wage Earners and Clerical Personnel (CPI-W), used to determine if Social Security recipients, federal retirees, and survivor annuitants will receive a Cost-Of-Living-Adjustment (COLA) in 2022, reflected a considerable increase from April-June 2021. Economists attribute much of the rise to increased consumer spending in the face of supply chain shortages as the economy seeks to recover from pandemic restrictions. Compared with the March 2021 CPI-W figure of 258.935, the April CPI-W was 261.237, the May CPI-W was 263.612, and the June CPI-W increased to 266.412. The June CPI-W figure is 1.06 percent higher than the May figure. Amazingly, the CPI-W figure of 266.412 for June 2021 is 5.13 percent higher than the average CPI-W for the third quarter of 2020, (July-September), which was 253.412. The 253.412 third quarter average for 2020 will be compared with the third quarter average for 2021 to determine if a COLA will be authorized in 2022. If this upward trend in the CPI-W continues through September 2021, it is very likely there will be a significant COLA in 2022. The July 2021 COLA is scheduled to be released on August 11.

### NARFE URGES MEMBERS TO SUPPORT THE FAIR COLA FOR SENIORS ACT (H.R. 4315)

NARFE strongly urges all members to contract their Congressional representatives and encourage them to support the passage of the Fair COLA for Seniors Act (H.R. 4315), which was reintroduced in the House of Representatives on 1 July by Congressman John Garamendi of CA. H.R. 4315, if passed by Congress and signed by the President, would change the basis for calculating Cost-Of-Living-Adjustments (COLAs) for seniors from the Consumer Price Index for Urban Wage Earners and Clerical Personnel (CPI-W) to the Consumer Price Index for the Elderly (CPI-E). While the CPI-W tracks the spending habits of the general urban workforce, it does not adequately assess the differences in costs for goods and services often purchased by seniors, such as medical care costs, which regularly have a higher rate of inflation than the overall cost of living. NARFE has strongly advocated for use of the CPI-E, which would be of significant help for seniors.

Get ready... we are going to live meetings beginning September 11, 2021. It will be so good to see all of you again.

I met with Congresswoman Yvette Herrell, Brian Kennedy, Deputy Chief of Staff, and Mark Mickelson, VP for Legislation, NM Federation via Zoom on May 17, 2021. We asked for the Congresswoman's sponsorship on H.R.82 which is the repeal of the Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP), and H.R.51, The Equal COLA Act which would give the Federal Employees Retirement System (FERS) employees the same Cost-of-Living Allowance (COLA) as the Civil Service Retirement System. I recently received a response from the Congresswoman, "According to the Social Security Administration, 69.1 million Americans received benefits in 2019. It is important that those who have paid Social Security for their entire lives are able to receive the benefits that they are entitled to. Unfortunately, Social Security Administration's 2019 Board of Trustees Report highlighted the Administration's unfunded obligations totaling \$13.9 trillion over the next 75 years, \$2.9 trillion in outstanding trust fund debts, and a prediction of insolvency by 2035. These astronomical numbers that highlight why it is imperative that we ensure this program is run in a fiscally responsible manner so that people can continue receiving the benefits that they pay for. If we do not, people will either pay exorbitantly higher taxes or lose benefits that they spent most of their lives paying for." The response did not state that she would not cosponsor the bill but it was implied.

September is our Annual Legislative Breakfast meeting and I have invited our Senators and Congresswoman to join us. Looking forward to seeing you again in September.
