Service Officer Report (Jim Kielty)

UP, UP AND AWAY! CONSUMER PRICE INDEX SHOWS ANOTHER SIGNIFICANT GAIN IN MARCH 2022



The Consumer Price Index for Urban Wage Earners and Clerical Personnel (CPI-W), used to determine if Social Security recipients, federal retirees, and survivor annuitants will receive a Cost-Of-Living-Adjustment (COLA) in 2023, increased sharply in March 2022 as inflationary pressures continued to drive up prices in many sectors of the economy. The March 2022 CPI-W was 283.176, 1.52 percent higher than the February 2022 CPI-W of 278.943. The 283.176 figure for March 2022 was 5.50 percent above the average CPI-W for the third quarter of 2021 (July-September 2021), which was 268.421. The 268.421 figure is the reference point which must be exceeded for a 2023 COLA to be authorized.

In October 2022 the CPI-W average figure for the months of July-September 2022 will be compared with the 268.421 average CPI-W for the months of July-September 2021. If the 2022 CPI-W average exceeds the 2021 CPI-W average, a COLA will go into effect in January 2023. The April 2022 CPI-W will be released on May 11.

If current trends continue, it is very possible that a COLA in January 2023 may well exceed the 2022 COLA, which was 5.9 percent for those under the Civil Service Retirement System (CSRS) and 4.9 percent for those under the Federal Employees Retirement System (FERS).
