### OPEN SEASON CONTINUES THROUGH DECEMBER 11



The Open Season for the Federal Employees Health Benefits Plan (FEHBP) and the Federal Employees Dental and Vision Program (FEDVIP) for the 2024 benefits year will continue through December 11. All Open Season changes for federal retirees and survivor annuitants are effective January 1, 2024 and premium changes are reflected on February 1, 2024 annuity payments. Open Season changes for current federal employees are effective at the beginning of the first full pay period on or after January 1, 2024.

FEHBP changes may be made online at <u>http://retireefehp.opm.gov.</u> by selecting "Open Season Online" FEHBP changes may also be made by calling Open Season Express at 1-800-332-9798. During Open Season federal retirees and survivor annuitants may also request changes and information by regular mail by writing to the U.S. Office of Personnel Management (OPM) at FEHB Open Season Processing Center, P.O. Box 5000, Lawrence, KS 66046-0500. When using this option, clearly state in writing your Open Season request. If you are making an enrollment change state the type of coverage (Self Only, Self Plus One, or Self and Family) you desire and the enrollment code. Remember to include your annuity claim number (CSA or CSF number) and your Social Security Number on your request.

With regard to dental or vision insurance under FEDVIP, enrollments, cancellations, or changes may be accomplished by computer at <u>http://www.benfeds.com</u> or by calling 1-877-888-3337.

There are numerous sources available to assist you in determining if you should make any changes during the FEHP/FEDVIP Open Season. These include the OPM website; the October, November, and December issues of the *NARFE* magazine: and the 2024 brochure of the plan in which you are presently enrolled, Section 2 of which reflects the plan's changes for 2024. Remember, there is no one health, dental, or vision plan which is best for all. However, by doing your homework, you will find the plan which best meets your needs.

## OCTOBER 2023 CPI-W SHOWS SLIGHT DECLINE COMPARED TO SEPTEMBER 2023 FIGURE



On November 14 the U.S. Bureau of Labor Statistics (BLS) announced that the October 2023 Consumer Price Index for Urban Wage Earners and Clerical Personnel (CPI-W), used eventually to determine if Social Security recipients, federal retirees, and survivor annuitants will receive a Cost-Of-Living-Adjustment (COLA) in 2025, was 302.071 compared with the September 2023 CPI figure of 302.257. This was a monthly decline of 0.06 percent.

At the end of September 2023, the average CPI-W for the third quarter of 2023, which was 291.907, will be compared with the average CPI-W for the third quarter of 2024 to determine if a COLA will be authorized in January 2025. The November 2023 CPI-W figure will be announced on December 12.





#### *Della Apodaca* Thank you for your contribution to NARFE-PAC!

We have met 46.8% of our chapter goal as of September 30. Nineteen Las Cruces chapter members contributed \$2,288 to NARFE-PAC, an increase of \$553 since the prior quarter. The 19 contributors represent just under ten percent of our chapter membership. The NM chapter with the highest dollar contribution was Las Cruces, followed by Albuquerque with \$1,411. Las Cruces makes up 50%, followed by Albuquerque at 31%, of dollar contributions in NM, respectively.

Overall, NARFE-PAC raised 44% of its \$1.6 million goal for the 2023-2024 cycle. Distributions increased \$73,000 to candidates. There were no additional distributions to NM candidates since the prior quarter, when a \$2,500 distribution was made to Senator Heinrich.

Consider making a voluntary contribution to NARFE-PAC\* today. Members can contribute through the mail via the form in the *NARFE* magazine, or at our next chapter meeting. Consider becoming a monthly sustainer via annuity withholding or through a credit card.

\*To comply with federal law, we must use our best efforts to obtain, maintain and submit the name, mailing address, occupation and name of employer of individuals whose contributions to NARFE-PAC exceed \$200 each calendar year. NARFE-PAC is for the benefit of political candidates and activities on a national level. NARFE members have the right to refuse to contribute without reprisal, and NARFE will neither favor nor disadvantage anyone based on the amount of a contribution or failure to make a voluntary contribution. The suggested amounts are only suggestions and not enforceable. Only members of NARFE may contribute to the PAC. Contributions from non-members will be returned. NARFE-PAC contributions are not deductible for federal income tax purposes.

## Legislation (Janice Bridges)



As a math person I looked at some numbers. Out of 11% of the bills that get introduced and make it to the floor to be voted on, only 2% actually get passed.



1. Advancing the Social Fairness Act H.R. 82/S.597: reducing social security payments if you get retirement pay from another source. 300 Co-sponsors as of Nov 21: 201 Democrats, 99 Republicans, Gabe Vasquez co-sponsored.

Only a 4% of being enacted...which is higher than the average of 2%. But PLEASE write on Senator Heinrich and Senator Lujan websites and express your support to enact this to protect our retirement pay!

2. Equal Cola Act H.R.866: Ensuring that FERS gets the same COLA raise as CSRS. Right now, FERS gets 1% less than CSRS gets. As of Nov 21, 43 co-sponsors: 40 Democrats and 3 Republicans, Gabe Vasquez co-sponsored.

Only a 5% of being enacted...which is higher than the average of 2%. But PLEASE write on Senator Heinrich and Senator Lujan websites and express your support to enact this to protect our retirement pay!

3. Budget items-- Protecting earned federal retirement and health benefits from potential cuts in the future. It was threatened for the FY 24 budget that no COLAS would be given to any FERS or CSRS retirees. We need to monitor who is voting to cut out our COLAS. I do not have that information yet. That has been a little harder to obtain.
