Thanks to all our members who took the time to vote and to our President for completing a proper ballot!!

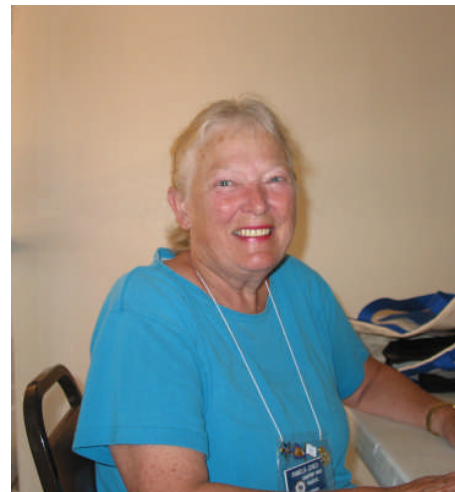
