Since our last issue there's been a lot going on around the state. I had the pleasure of attending the National Legislative Conference in March, along with Sharon Reese and Judy Rosco of Chapter 182. You will receive in-depth information of the Conference at the April Workshop(s). Yet, I want to share the "take aways" that I experienced.

- 1. The Headquarters Legislative staff continues to impress and demonstrate the utmost intelligence, commitment and professionalism representing our interests with Congress, but also providing the analysis and explanation of issues for our use locally.
- 2. Members of Congress care what constituents think
- They need support for re-election
- 3. Our objectives need to Strengthen Grassroots efforts
- Information is out there and available to keep informed; e.g. frequently check the Legislative Action Center webpage (Headquarters) and your e-mail, ask questions at Chapter meetings, make phone calls to Congressional leaders, write letters to Congressional leaders, heed calls-to-action, listen to Headquarters Legislative webinars; follow NARFE on Facebook
- Pressure potential opponents; support our friends
- Keep it simple/make it personal/ask for action
- Be proud of being part of Federal Community and a member of NARFE wear NARFE gear at community events
- Let your Chapter Legislative officer or the Federation Legislative VP know if you took action, etc.
- 4. NARFE is non-partisan
- The Association supports Congressional Leaders supportive of Federal Community regardless of party affiliation.

- NARFE meetings need to reflect this non-partisan view in order for ALL members to feel welcomed & included.
- In this divisive time in our political environment, regardless of other opinions on many current social or political issues and/or dislike or support of specific elected officials that members care about, NARFE is about threats to Federal Employee/Retiree benefits and pay and what's also true, members need to be informed and empowered around those issues to take action by voicing their concerns or agreement with their Congressional Leaders. Other organizations abound for all members to affiliate with to champion other important state or national issues.

- Current Strategic Planning Committee efforts
- The state of Service Officers Function and training
- Implementation of One-Member-One-Vote by Federations (OMOV) and Optional Chapter Membership (OCM) via by-laws revisions by Federations and Chapters. Ntl Sec/Treasure stated: Federations' bylaws compliance with OMOV and OCM should occur by January 1, 2018, for those with meetings in 2017. For those with meetings in 2018, federations' bylaws should be modified by January 1, 2019. (New Mexico

Federation By-Laws committee working to have draft available for voting at the 2018 NM Convention)

New Mexico NARFE-PAC

Jason Freeman of National shared some very interesting information with me today (4/10/17).

"NARFE-PAC raised \$226,828 in the first quarter (more than the \$212,555 raised in the first quarter of 2015-2016 cycle). In New Mexico, 70 members contributed \$2,807.50. That is a big increase from the first quarter of the last cycle, when roughly 61 members contributed \$1,882."

"In New Mexico NARFE-PAC disbursed \$1,500 in connection with a Federal-Postal Coalition fundraiser we attended in DC. This check was given to Senator Martin Heinrich. In general, we're being more aggressive in our disbursements, making more earlier in the year. In the first quarter, we disbursed \$146,500, of our \$1 million disbursement goal."

You can make new members or transfer members feel welcome – and aid them in finding an opportunity to assist with their talents in volunteer positions for your Chapter. Each member is needed!

So many things have happened this past year from NARFE National Convention that we now have many more important things to accomplish. Chapter 182 has taken the bull by the horns and conducted what they called the "Grand Voting Experiment". They followed through on the "One Member - One Vote" process. This was easier for them because they have a newsletter which goes out each month, to every Chapter member. They accomplished the balloting by email and snail mail. The problems were still there, (1) A member felt this should be a secret ballot. This is very hard to do because you must be a Chapter member to vote and having no guidance from National at that point they stuck with the identity of the Chapter member. (2) Some members had difficulty with returning the ballot by email. As you can see, it cannot be a secret ballot because the returners email address is plain to see. Now the chapter has solved the problem of returning email ballots and this will be discussed at the workshop. We will all be glad when National addresses these same problems.

The other thing we have all been looking at is the Bylaws changes. I have not heard from any of my Chapters on this subject. This is one of the things we will be discussing and the Workshop. All Chapters should keep in mind that they do not have to wait for the Federation to complete their Bylaws before they send theirs to National for approval.

I am looking forward to seeing all of our Southern New Mexico Chapters at the Workshop in T or C on April 28th and 29th. We always have a good time and get to see many longtime friends in NARFE.

The Legislative Conference held in Alexandria, VA March 12-15, 2017 was the most successful one yet. There were 303 registered attendees with 168 first time attendees. The New Mexico attendees were Judy Rosco, Chapter 182 Vice President, Lorna Howerton, Federation, and myself. It was Judy and Lorna's first Legislative Conference.

It was also a first with a couple of sessions being shared with the Federal Managers Association. This worked well and hopefully will continue in future conferences.

Speakers at our plenary sessions included: FMA President Renee Johnson, FEEA Executive Director Joyce Warner, Representative Anthony Brown (D-MD), Representative Jamie Raskin (D-MD), Representative Barbara Comstock (R-VA), Senator Heidi Heitkamp (D-ND), Cliff Johnson from National Journal, Representative Rob Witman (R-VA), and Representative Don Beyer (D-VA). Breakout Sessions were: Tailoring Your Message: Making the Most of NARFE's Hill Day; It Takes a Meeting (and Practice); An In-Depth Look at NARFE PAC; and Using NARFE's New Advocacy Tools. Optional Break-Out Sessions on Tuesday at 5:00pm: State Advocacy, Train the Trainer; Social Media; and Ask the Experts. I attended State Advocacy and Judy attended Social Media.

Our Day on the Hill included meetings with: Senator Tom Udall staffers, Senator Martin Heinrich (spoke to him personally at his coffee) and staffers, Representative Michelle Lujan-Grisham staffers (the Congresswoman was flying back from NM), Representative Pearce staffers, and Representative Ben Lujan and staffers.

Federal Retiree and Employee Health Benefits Cuts

Effective Pay Cuts for Current Employees Through Benefit Reductions

Elimination or Reduction of Retirement Security for New Hires
